Parent-Student Release/Consent Form

(Detailed information on these policies and all the other center policies and rules are clearly described in the Parent/Student Handbook. Please come and see Miss Jaye at any time with any questions)

◆ **TUITION - Payment of Tuition is due on the 1st class of each month OR in your tri-monthly installment payments on the 1st of Sep, Dec & Mar.** Your payment secures enrollment in the class and does not adjust due to absences. A \$10 fee will be charged for any payments made after the 10th of the month. **TUITION REMAINS THE SAME EACH MONTH REGARDLESS OF WHETHER IT IS A 5 WEEK MONTH OR A SHORTENED MONTH DUE TO HOLIDAYS.** Tuition is not pro-rated, refunded or credited for missed classes or Holidays.

◆ For checks returned for insufficient funds there is a \$25.00 returned check fee. If this happens 2 times then you may continue with class but must pay tuition with cash only.

◆ Registration Fees are NON-REFUNDABLE. In addition – Tuition fees are NON-REFUNDABLE unless a class is canceled by the teacher/studio. Your tuition secures your spot in class and we turn others away when you are enrolled, therefore if you choose to withdraw from class you must do so in writing and any pre-paid tuition is forfeited.

◆ **REFERRALS** – Of course word of mouth and your recommendations are what keep any business strong and growing. We fully appreciate all recommendations you can give on behalf of the studio. To show our appreciation you will receive \$10.00 credit to your account for every referred child that registers. Please make sure the person you referred give us your name!

◆ All dancer accounts must be paid in full by June 1st in order to perform in the end of the year recital.

◆ **COSTUMES:** NO costumes will be handed out to be taken home until they have been paid for in full. Most costumes will need some alterations as they are made for general size ranges and not each dancer's specific body. You may alter them yourselves or give them to Premier Dance to have altered at a reasonable fee.

◆ In an effort to maintain order and safety and be able to instruct your children appropriately we reserve the right to remove a child from the dance floor, or at last resort, discontinue them from the program if their behavior is disrupting the class or causing unsafe conditions.

◆ **DANCE ATTIRE:** There is no dress code for our recreational combination classes, HOWEVER, NO JEANS are to be worn in dance class and hair must be pulled back securely. Proper dance shoes must be worn AT ALL TIMES – For more detailed information on the dress/shoe requirements please refer to your Parent/Student Handbook.

◆ **STUDIO SAFETY/CLEANLINESS:** We try to make our waiting area as comfortable and inviting for families as possible, but we it is a large area and leaves room for running and playing. We ask that you please supervise your other children at all times and do not allow them to run through the building or climb on the walls or props. We also understand that it is impossible to avoid all snacks from the waiting room but please check your area before leaving and if your children have left crumbs or wrappers, or a mess of any kind, we kindly ask you to pick that up as it is a lot of work to keep the studio clean on any given day as it is, and when there are messes from food and playing it just makes it more difficult and time consuming for us.
